We will need something in writing prior to cleaning anything out.

### **CLERKS REPORT**

The Clerk asked the board to approve appointing Kay Kristof as an election inspector to help with the upcoming election. Dennis Thornton made a motion to approve the request, seconded by Harold Polzin, all in favor, none opposed, motion carried.

### AGENDA ITEMS

Alvin talked about having a Fence, driveway Ordinance saying a fence should be set back the first 25 feet from the center of the road, next 10 feet should be low enough to see over, then the next section could be higher but would need to coordinate with the county shoreline ordinance.

IN discussing the tree located on Gayhardts property in the town right away it decided that for safety reasons the tree will need to be cut down to at least three feet.

Dennis Thornton stated that instead of changing our whole zoning ordinance we could just add a fence and driveway section to our existing ordinance.

We will table the Treasurer's Bond ordinance until November.

### **CHAIRMAN'S REPORT**

Alvin stated that ditching on Rosebrook needs to be done yet. Alvin thought maybe we could have the new firehouse open on election day, we will discuss later. Alvin also stated that in one week he wrote out building permits for buildings that will be worth over 1.3 million dollars. County M is now ATV/UTV from Shawano to Spruce road.
