PUBLIC COMMENTS:

Dick Hesse stated that Scott Nordin is waiting for an update for the firehouse addition.

CLERKS REPORT

The Clerk read the minutes from the August 13, 2018 meeting. Harold Polzin made a motion to approve the minutes, seconded by Dennis Thornton, all three in favor, none opposed, motion carried. Sue Briggs from the area home school group asked if it is possible to use the town hall every other Wednesday morning. The board did not see any problem with that.

NEW FIRE TRUCK

At a recent fire department meeting, it was mentioned that the city of Shawano will be purchasing a smaller fire truck than what they had first talked about. This truck is estimated to cost about \$325,000.00. Belle Plaine will need to pay 10% of that total over the next two years. In about five years from now our present town fire truck will be replaced.

FAIR STAND

Alvin stated that the fair stand grossed this year \$28,000.00.

GREEN PROPERTY

The Greens are trying to sell a cottage on Pine Lake and there some concerns about the driveway. There should be something in the Feb 1970 minutes saying that a parcel was given to the town to help with an easement to get back to this cottage. Harold Polzin said he will come to the town hall and try some information in the minutes.

CHAIRMAN'S REPORT

Alvin also stated a couple of other items: East Central Planning has limited projects that they can help with; we are still trying to get out Comprehensive plan completed this fall. The owners of the old Dock tavern would like to remove the existing screen porch and put a deck on instead.

Alvin stated that the equalized values are up 2% in Belle Plaine.

SUPERVISOR REPORT

WELL WATER TESTING

Dennis Thornton gave an update on the well water grant he is applying for. It is completed and ready to be approved. It must first go to the courthouse for approval and then Dennis will go to Florence to present it to the Lumberjack committee. We may be doing this testing on Memorial Day weekend; the hopes are to have 100 residents participate. Dennis also stated he is finishing up the newsletter. An article in the newsletter will be about the volunteer participation of students to help with Gibson Island upkeep.
