Prior to the regular board meeting, the Zoning Committee meet, present were Richard Pahlow Zoning Committee Chairperson, Greg Riesenberg, Bonnie Utke, and Dick Hesse.

Is was reminded that August 24,2021 Comprehensive Plan meeting in Shawano at 5:30 pm.

The committee went over zoning request changes.

- 1.Dan Dillenburg property located at W9618 Angle Road, parcel number 063400000 requests to connect existing house and buildings to Range Line Road, after discussion Dick Hesse moved to approve connecting 2 ½ acres into a right of way to the road to get in and out, Greg Riesenberg seconded the motion, all in favor none opposed, motion carried.
- 2. Raymond Zogleman who purchased the llama farm requests to change the 20-acre parcel to commercial so that he can use this a venue for special occasions, motion was made by Greg Riesenberg to accept the change, seconded by Bonnie Utke, all in favor, none opposed, motion carried.
- 3. Kraig Rosenow preliminary certified survey map does not appear to meet setbacks, Dick Hesse questioned if the property should be at least two acres seeing there is a large barn located on the property but not much a person could do without some land. Alvin Bartz will recommend changing this parcel to be at least two acres before approving the certified survey map.

At 7:30 pm Richard Pahlow made a motion to adjourn the zoning meeting, seconded by Bonnie Utke, all in favor, none opposed, motion carried.

Steve and Molly Joosten questioned if we had a room tax ordinance and would like to have a copy of it, they also suggested having a town form to fill out if someone was renting out a cottage to make it easier when submitting tax money, the Clerk will put a form together and send this information to them. Molly is also in the process of trying to bring back the Art Fair that used to be held at the Roundlake shelter in the summertime, if she unable to get enough interest for this year but hopefully next year will work.

Ellen Walbrun who lives at N2553 Rustic Drive said the bush that is located on Mark and Linda Gayhart's property needs to be trimmed again, it is hard to see when backing out of their driveway. Dick Hesse will talk to them.

CLERKS REPORT

The Clerk read the minutes from the July 12,2021 meeting, Cory Retzlaff made a motion to approve the minutes as read, seconded by Wade Wisnefske, all in favor, none opposed motion carried.

CHAIRMAN'S REPORT

FIRE MEETING

Alvin stated there will be a fire meeting on Tuesday at the Shawano Fire house. They will be discussing a five-year project on purchasing a new fire truck. The towns of Richmond, Waukechon, Belle Plaine and Wescott will each pay their portion of the purchase. Half of the cost of the truck will be paid in 2023 and the other half will be in 2028.

TIPPING FEES

Alvin also talked about tipping fees, with the constant rise in prices, we need to find ways to cut costs.

BPW DISTRICT

Chris Prey Clerk for the town of Waukechon, takes care of invoicing and reports for the BPW Sanitary District, at this time she receives\$1500.00 per year, Alvin would like this put on the September agenda to discuss giving her a raise.

WEB SITE

The Clerk is taking over updating the town web site, Cory Retzlaff made a motion to approve spending \$500.00 to do so. Seconded by Wade Wisnefske, all in favor, none opposed, motion carried.

JOB POSTING

Wade Wisnefske made a motion to post the Treasurer position in the Market Messenger for two weeks, seconded by Cory Retzlaff, all in favor, none opposed, motion carried.

SUPERVISOR REPORT

Cory Retzlaff talked about possibly putting in a ditch by Nate Retzlaff's field. He also discussed getting updates on the letters to Roger Pahlow and Arland Dillenberg, Alvin stated that he would follow up with them

TREASURER'S REPORT

The Clerk went over the bills that need to be paid, Wade made a motion to accept the bills as presented, seconded by Cory, all in favor none opposed, motion carried.
