### **CLERKS REPORT**

### **CLEAN UP AND WEDDING ON GIBSON ISLAND**

Wade made a motion to approve letting a wedding take place on Gibson Island on September 10,2022, seconded by Cory Retzlaff all in favor, none opposed, motion carried. There will also be volunteers starting to work on Gibson Island to clean up fallen and dead trees. A liability form will need to be completed and kept on file during the clean up process. ### **OPERATOR AND PICNIC LICENSE**

A motion was made by Wade Wisnefske to approve the picnic license for the Clover Bares Snowmobile Club fishing derby which is usually held the first part of February, seconded by Cory Retzlaff, all in favor for both, none opposed, motion carried.

### **TOWN ADVOCACY**

A motion was made by Wade Wisnefske, seconded by Cory Retzlaff to approve sending a check for \$449.79 to the Wisconsin Towns Association so that Belle PLaine can become a part of the advocacy. They do many good things for town government.

### **RECYCLING CENTER**

Marie Rouse will continue to work at the Recycling Center until Jim Retzlaff is able to return. A motion was made by Wade Wisnefske to change the dump hours on Saturdays to 9am -12pm starting on April 1<sup>st</sup>,2022, seconded by Cory Retzlaff, all in favor, none opposed, motion carried.

### **CHAIRMAN's REPORT**
