### **PUBLIC HEARING FOR 2023 BUDGET**

Alvin Bartz town Chairman went over the proposed 2023 budget and revenues. He stated we will be closing the dump on December 31, 2022. He also stated that within the next year or two we will need to do a reevaluation of properties due to non-compliance. Alvin then asked if there were any questions or comments about the budget. It was stated that our contract from Harter's went up 4% plus the surcharge for fuel. Shanda Hubertus asked if we have checked around for pricing of other garbage haulers? With no further questions or comments the town hearing was closed at 7:40 pm.

### **SPECIAL TOWN MEETING**

At 7:40 pm a special town meeting was held to approve total 2023 Highway Expenditures pursuant to Section 81.03(3) of the Wisconsin Statutes and to adopt the 2023 Town Levy to be paid in 2023 pursuant to Section 60.01(1) of the Wisconsin Statutes. Glen McMann made a motion to approve the highway expenditures and the Town levy, seconded by Kevin King, all in favor non opposed, motion carried.

At 7:45 pm Al Prudom made a motion to adjourn the special town meeting, seconded by Glen McMann all in favor non opposed, motion carried.

### **MONTHLY TOWN MEETING**

At 7:45 pm Alvin Bartz Chairman called to order the regular town meeting, present for roll call was Wade Wisnepske Supervisor #1, Cory Retzlaff Supervisor #2, Kristine Vomastic Clerk and Colleen Weishoff Treasurer.

## **CLERKS REPORT**

The Clerk read the minutes from the October 10 and 17 2022 meetings. Wade made a motion to approve the minutes seconded by Cory, all three in favor non opposed, motion carried.

## **APPROVE 2023 BUDGET**

Cory made a motion to adopt the 2023 budget, seconded by Wade Wisnefske, all in favor non opposed, motion carried.

## **APPROVE CSM MAP FOR MAGEE'S.**

Wade made a motion to approve the Certified Survey Map for the Magee's which will allow their son to build a house on Town Line Road. Lots are all 1 acre each. Seconded by Cory Retzlaff, all in favor, none opposed, motion carried. When the original comes Alvin can sign and return.

## **DISCUSS HOUSE TO HOUSE PICK UP**

Kevin King mentioned that when the Recycling Center is closed there may be more garbage dumped in the ditches. Wade stated that he will get the camera up at the Recycling Center so that people won't be dropping their garbage off by the fence. We may need to have a cleanup time for residents once or twice a year.

Shanda Hubertus stated that there is grant money out there for recycling costs to hold events like that.

## **CHAIRMAN'S REPORT**

Alvin turned over the bill from June Peters who cuts the grass at Bomke Cemetery, he also stated that some fencing at the cemetery needs some repair.

## **SUPERVISOR REPORT**

Cory talked about the outlet on the Cloverleaf lakes, he stated to do any cleaning or changes with the outlet you must go through Scott Koenke from the DNR.

## **TREASURER'S REPORT**

Colleen Weishoff Treasurer went over the bills and finances.

Wade made a motion to approve the Treasurers report, seconded by Cory, all in favor none opposed motion carried.

Cory made a motion to adjourn, seconded by Wade, all in favor none opposed motion carried.
