**TREASURER'S REPORT**

## **CHAIRMAN'S REPORT**

Alvin discussed condition of the roads in Belle Plaine. It was decided that two roads will be done due to the costs to redo or repair.

Frontier is burying fiber optics in our area.

Gibson Island will begin the project soon for tree clean up, moving and redoing the isthmus (gravel is taken care of 100%) and replanting native plants.

Alvin stated we may not do any crack filling this year due to the budget. He also stated that so far this year we have three new homes going to be built in our area.

He had an oak wilt complaint concerning someone cutting up oak trees which is ok to do at this time.

Alvin asked if we could have the Market Messenger be our official newspaper because everyone gets that and not many get the Shawano Leader anymore. The Clerk will check into this and put on the June agenda.

The costs of a new fire truck in four years are estimated to be at \$70,000 for the town.
